ORDER

WHEREAS, the recognition was granted to the institution, namely, Chopda Education Society's College of Education, Chopda, Dist.-Jalgaon, Maharashtra for B.Ed. course of one year duration from the academic session 2000-2001 vide Order No. WRC/5-6/2k/10969-974 dated 12.12.2000 for an annual intake 80 seats followed by enhancement of intake to 100 vide letter dated 25.02.2005.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014 the Revised Recognition Order was issued to the institution vide order No.WRC/OAPW0415/113021/2015/146173 dated 31.05.2015 for conducting B.Ed. programme of two-year duration with an annual intake of 100 students (Two Basic Units of 50 Students Each) from the academic session 2015-2016.
- 3. AND WHEREAS, the institution had requested vide letter dated 29.08.2020 for permission to reduce the intake in B.Ed. course from 2 Units (100) to 1 Unit (50) seats.
- **4. AND WHEREAS,** the matter was considered by WRC in its 329th meeting held on 17th-19th February, 2021 and the Committee observed as follows:-

"The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

- 1. Recognition was granted to the institution for B.Ed. programme 100 seats vide order dated 25.02.2015.
- 2. Revised Recognition Order was issued for two units of 50 students each (100 intake) vide order dated 31.05.2015.
- 3. The institution vide letter dated 29.08.2020 has requested to reduce the intake from two unit (100 seats) to one unit (50 seats)

In view of above, the Committee decided as under:

- 1. The Committee accepted the request of the institution.
- 2. Revised Recognition Order be issued to the institution reducing the intake from two units (100 intake) to one unit (50 intake) from the academic session 2021-22 for B.Ed. programme.

- 3. Show Cause Notice be issued to the institution to submit the compliance of RPRO at least one unit within 30 days, failing witch recognition of the institution will be withdrawn."
- 5. NOW THEREFORE, in terms of decision taken by WRC, the permission is hereby granted to Chopda Education Society's College of Education, Chopda, Dist.: Jalgaon, Maharashtra for reduction of intake in B.Ed. course from 2 Units (100) to 1 Unit (50) seats.

6. The other terms and conditions shall remain same as mentioned in the revised recognition order issued dated 31.05.2015.
